The Bank invites Companies to tender for DESIGN AND BUILD FOR REPLACEMENT OF THE ARTIFICIAL GRASS FOOTBALL PITCH AND ASSOCIATED STORMWATER CONTROL WORKS AT THE BANK OF BOTSWANA SPORTS FACILITY, PLOT 61717, GABORONE, TENDER REFERENCE NO: BOB/2026/06/38

1. The Procurement Method is, Open Domestic Bidding.
2. The Evaluation method is, Least cost selection for works.
3. Tenderers must, in order to be considered for award of this contract, be registered with Public Procurement Regulatory Authority (PPRA) under **Grade E – Code 06: Specialised Construction Works**, with **sub-code: 01 Sports fields (turf and running track)**.
